Volunteer Release

WHEREAS, the undersigned will be in the Cedar Rapids, Iowa area working as a volunteer on projects which are sponsored in whole or in part by Linn Area Long Term Recovery Coalition, Block by Block, Cedar Valley Habitat for Humanity, Inc. and Church World Service.

WHEREAS, the undersigned desires to release and hold harmless, LALTRC, Block by Block, Cedar Valley Habitat for Humanity, Inc, Church World Service its officers, directors, members, sponsors, volunteers and any other organization involved directly or indirectly.

NOW, THEREFORE, in consideration of the undersigned working on projects sponsored by LALTRC, Block by Block, Cedar Valley Habitat for Humanity, Inc and Church World Service the undersigned hereby releases and discharges LALTRC, Block by Block, Cedar Valley Habitat for Humanity, Inc and Church World Service its officers, directors, members, sponsors, volunteers and any other organization involved directly or indirectly, present and future, known or unknown, in any matter arising out of the project; further the undersigned specifically assumes all risk involved in travel and work on the projects and all activities surrounding the projects.

It is the policy of the LALTRC, Block by Block and Cedar Valley Habitat for Humanity, Inc that children 15 years of age and under are not allowed on a worksite where there is construction in progress. It is further the policy that while children between the ages of 16 and 18 may be allowed to participate in construction work, hazardous activity such as using power tools or working on rooftops, is not permitted by anyone under the age of 18.

I understand that the LALTRC, Block by Block, Cedar Valley Habitat for Humanity, Inc and Church World Service does not carry or maintain any health, medical or disability insurance coverage for its volunteers, and I am expected to carry my own personal health insurance and liability insurance. I understand that I hereby release and forever discharge the LALTRC, Block by Block, Cedar Valley Habitat for Humanity, Inc and Church World Service from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer Activities.

The undersigned will never institute any action or suit at law or in equity against LALTRC, Block by Block, Cedar Valley Habitat for Humanity, Inc and Church World Service its officers, directors, members, sponsors, volunteers and any other organization involved directly or indirectly, nor institute, prosecute or in any way aid in the institution or prosecution of any claim, demand, action or cause or action for damages, cost, loss of service expenses or compensation for or on account of any damage, loss, or injury, either to person or property, or both, whether developed or underdeveloped, resulting or to result, known or unknown, past or present or future, arising out the undersigned working with LALTRC, Block by Block, Cedar Valley Habitat for Humanity, Inc and Church World Service on the Cedar Rapids, Iowa projects.

Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court or competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions in this Release which shall continue to be enforceable.
